### GENERAL PROVISIONS

- The fees and commissions stipulated in the present Tariff are valid unless otherwise arranged. Specific services not included are subject to additional arrangement.
- All fees and commissions shall be collected in EUR or the equivalent in another currency calculated based on fixed rate of BNB on the day of transaction.
- Ryvyl (EU) EAD is entitled to debit any other account of the client with the accrued fees and commissions, even in the equivalent in other currency, if there is no sufficient cover on the respective account.
- All additional expenses related to the execution of the orders, including those of Bank partners, are collected in addition to the items specified in the present Tariff.
- Ryvyl (EU) EAD reserves the right to apply additional charges for specific instructions or requirements, leading to extrawork, unusual complexity and/or liability.
- The present Tariff will be applied immediately for all new Merchants and from 01.04.2024 for all current Merchants.
